2.	The WVAC will apply reasonable care and diligence in respect of any property of the exhibitor placed in the care or control of the WVAC by the exhibitor in connection with an exhibition, function or performance managed by the WVAC and the exhibitor will either separately insure the exhibitor's property against damage, theft or loss, however arising or hereby indemnify the WVAC against all claims in connection with the exhibitor's property, whether by third parties or otherwise and hold the WVAC harmless. 3.	The WVAC may in its absolute discretion exhibit the exhibitor's property for sale, at a price agreed herein, at the premises for the three week period of the exhibition. The WVAC will acquit any sale, deducting its 25% commission from the gross purchase price and remitting the balance to the exhibitor within 30 days from the end of the exhibition.			
4.	The exhibitor shall promptly pick up and remove all unsold property, 2pm to 4pm, on the final Sunday of the exhibition. The WVAC will not take any responsibility for storing property outside the terms of this agreement.			
5.	The WVAC shall maintain a policy of public liability insurance in respect of the premis	es.		
6.	Entry will grant WVAC a license to reproduce the art works entered for non-commercial purposes. At all times the copyright in the works exhibited shall remain the property of the exhibitor and the exhibitor shall indemnify and hold harmless the WVAC in respect of any contested copyright or ownership claims including claims by third parties.			
7.	Any awards, prizes or commendations in relation to the exhibition shall be at the absolute good faith and discretion of the WVAC and/or any judges it may employ and the exhibitor agrees not to contest or challenge any such decisions. The exhibitor acknowledges that no correspondence will be entered into on the exercise of this discretion.

CONDITIONS OF ENTRY

CONDITIONS OF ENTRY

ENTRY FEE

\$10 per entry. Maximum 1 entry per artist (no diptych style pieces this year). Entry fees are non-refundable. The WVAC is a non-profit volunteer community group that manages the Wollombi Cultural Centre for the artistic and cultural needs of the community. The WVAC's role is to foster the arts. An artist is deemed "emerging" when they have not had a solo exhibition in a commercial gallery (not for profit galleries including artist run spaces are not included).

ENTRIES and AWARDS All artworks must have been produced within the last 2 years to be eligible. Previous entries will not be accepted. The WVAC reserves the right to refuse works that do not comply with these conditions of entry or at its absolute discretion. All works must be for sale.

OPEN Emerging Artist Award: \$1,500 Highly Commended Award: \$700 Commended Award: \$500 Under 18 Awards: \$200 & \$100 Under 12 Awards: \$100 & \$50 Wollombi Prize: \$500 (local subject matter or local artist) 2325 Local Australian Flora Award \$500 (subject matter & local artist) Photographic Award \$300 Performance Art Award \$200 - entry via short video (max 3 minutes) People's Choice Awards: \$250, \$100 (announced at close of exhibition)

COMMISSION The WVAC commission on sale of works exhibited shall be 25% of the gross sale price. The WVAC will acquit any sale, deducting its commission from the gross purchase price and remitting the balance to the exhibitor within 30 days from the end of the exhibition.

PRESENTATION Works must have attached "D" rings 7& wire ready for hanging – no exceptions. Wet works and diptych pieces will not be accepted.

JUDGING Any awards, prizes or commendations in relation to the exhibition shall be at the absolute good faith & discretion of the WVAC and/or any judges it may choose and the exhibitor agrees not to contest or challenge any such decisions. The exhibitor acknowledges that no correspondence will be entered into on the exercise of this discretion.

FREIGHT, PACKAGING, INSURANCE Entrants must make their own arrangements with carriers for return of entries. All freight charges are to be paid by the entrant. Damaged artworks will not be accepted. The WVAC will apply reasonable care and diligence in respect of any property of the exhibitor placed in the care or control of the WVAC by the exhibitor in connection with the exhibition but shall not be responsible for any damage or loss suffered by the exhibitor. We advise works to be insured by the exhibitor. The WVAC shall maintain a policy of public liability insurance in respect of the premises (please refer to Exhibition Agreement).

IDENTIFICATION Label the back of your work with: Title of work and your name, address, phone, medium, sale price and directional arrow. Please make sure your work is signed. Also ensure these details and a short description is included on the entry form.

COPYRIGHT Entry will grant WVAC a license to reproduce the art works entered for non-commercial purposes. The exhibitor warrants that the entry is an original work and shall indemnify the WVAC against any third party claims of breach of copyright.

MAXIMUM SIZE OF ENTRIES **Hung works: 100 x 120cm.** Freestanding works (including all 3D, sculptures, ceramics and installation works): 100hx100wx100d cm. Sculptures can also be displayed in the garden adjacent to the gallery. These are not limited to a particular size but are restricted to space available. Delivery and pick-up is to be both organised and undertaken by the entrant.

RECEIVING AND COLLECTION OF ARTWORKS Works will be received the Sunday before the official Opening date - between noon - 4pm. Works not received by 4pm on this Sunday will be ineligible and entry fees will be forfeited. Any technical aspects of an installation are to be organised by the entrants. Sold and unsold works will be available for collection the final Sunday of the exhibition between noon and 4pm. The WVAC will not take any responsibility for storing property outside the terms of this agreement and unsold works not picked up by the exhibitor may be disposed of at the discretion of the WVAC

SUBMITTING OF ENTRY FORM AND ALL FEES Entries must be written on a copy of the entry form and sent together with \$10 entry fee and a signed WVAC Emerging Artist Exhibition Agreement by postmarked 5.00pm the Monday before drop off date.
